SUBJECT: Resolution to Approve Intervention in Property Tax Appeal Board Case

### DISCUSSION:

Camp Street Crossing LLC ("Property Owner") has appealed the denial of the Tazewell County Board of Review regarding the Property Owner's requested reduction of the equalized assessed value ("EAV") of the Property Owner's parcel in the Camp Street Crossing development. This appeal is taken to the State of Illinois Property Tax Appeal Board (PTAB). The applicable State law requires that prior to intervening in a PTAB case to contest the Property Owner's requested reduction in EAV of private property of over \$100,000.00, the City Council must adopt a resolution approving the City's intervention in the PTAB case.

This Resolution approves the City Attorney's Office, on behalf of the City, intervening in this pending PTAB case so that the City can be heard and can contest the significant proposed reduction in EAV for this property.

**WHEREAS**, the City of East Peoria ("City") objected to the requested change in assessed value; and

**WHEREAS**, the Board of Review has affirmed the assessment originally assigned to the Property; and

**WHEREAS**, the owner of the Property has appealed the decision of the Board of Review to the Illinois Property Tax Appeal Board ("PTAB"); and

**WHEREAS**, it is in the best interests of the City to intervene in the proceedings currently pending before PTAB;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF EAST PEORIA, TAZEWELL COUNTY, ILLINOIS, THAT** the Attorney for the City is hereby authorized and directed to obtain an appraisal for the Property and petition for leave to intervene in the proceeding involving the assessment of the Property, which proceeding is identified as Docket No. 2019-00177.001-C-2 currently pending before the Illinois Property Tax Appeal Board.
