SUBJECT: Resolution to Approve Intervention in Property Tax Appeal Board Case

DISCUSSION:

Kroger Limited Partnership I (the "Property Owner") has appealed the denial of the Tazewell County Board of Review regarding the Property Owner's requested reduction of the equalized assessed value ("EAV") of the Property Owner's parcel in East Peoria. This appeal is taken to the State of Illinois Property Tax Appeal Board (PTAB). The applicable State law requires that prior to intervening in a PTAB case to contest the Property Owner's requested reduction in EAV of private property of over \$100,000.00, the City Council must adopt a resolution approving the City's intervention in the PTAB case.

This Resolution approves the City Attorney's Office, on behalf of the City, intervening in this pending PTAB case so that the City can be heard and can contest the significant proposed reduction in EAV for this property.

**RESOLUTION AUTHORIZING CITY ATTORNEY'S OFFICE TO INTERVENE
IN CASE BEFORE THE ILLINOIS PROPERTY TAX APPEAL BOARD**

WHEREAS, Kroger Limited Partnership I, the owner of Parcel No. 01-01-32-414-008 (the "Property"), has filed a complaint with the Tazewell County Board of Review (the "Board of Review") for the purpose of challenging the assessed value assigned to the Property for tax year 2020; and

WHEREAS, the City of East Peoria ("City") has objected to the change in assessed value; and

WHEREAS, the Board of Review has affirmed the assessment originally assigned to the Property; and

WHEREAS, the owner of the Property has appealed the decision of the Board of Review to the Illinois Property Tax Appeal Board ("PTAB"); and

WHEREAS, it is in the best interests of the City to intervene in the proceedings currently pending before PTAB;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF EAST PEORIA, TAZEWELL COUNTY, ILLINOIS, THAT the Attorney for the City is hereby authorized and directed to obtain an appraisal for the Property and petition for leave to intervene in the proceeding involving the assessment of the Property, which proceeding is identified as Docket No. 2020-01203 currently pending before the Illinois Property Tax Appeal Board.
