SUBJECT: Emergency Water Tower Repair

DISCUSSION: Emergency Repair of the Pekin Ave. Water Tower

The Pekin Ave water tower began leaking from the bottom of the bowl on 8/29/2021. The water tower was drained, and an inspection was performed to determine the best method of repair. The bottom section of the bowl had been repaired previously and those repairs had deteriorated to the point of failure. We decided the best long-term repair was to remove the entire bottom section of the bowl and replaced with new custom-made steel plates. An epoxy paint was then applied to the repair to protect the tower from future corrosion.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF EAST PEORIA, TAZEWELL COUNTY, ILLINOIS, THAT the emergency repair of the Pekin Avenue Water Tower completed by Central is hereby approved, and the Treasurer is hereby authorized and directed to pay the sum of \$15,000.00 to Central Tank Coatings, Inc. for the completion of the Emergency Repair Project as specified in the Central Invoice.
