SUBJECT: Ordinanace <u>4661</u> Update (10-1-4.16. Sniffing or inhaling of intoxicants prohibited)

DISCUSSION: 10-1-4.16 of the City Code was updated to bring the fine more in line with the seriousness of the offense. The new fine is not less than \$150, nor more than \$750 with a subsequent offense increasing the fine to not less than \$250, nor more than \$750.

RECOMMENDATION: Approve update to ordinance 4661.

ORDINANCE NO. <u>4661</u>

AN ORDINANCE AMENDING TITLE 10, CHAPTER 1 OF THE EAST PEORIA CITY CODE TO INCREASE THE PENALTY FOR SNIFFING OR INHALING OF INTOXICANTS

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF EAST PEORIA, TAZEWELL COUNTY, ILLINOIS, THAT:

Section 1. Title 10, Chapter 1, Section 4.16 of the East Peoria City Code is hereby amended as follows (additions indicated by underline, deletions by strikethrough):

10-1-4.16. Sniffing or inhaling of intoxicants prohibited.

- (a) It shall be unlawful for any person to sniff, inhale or breathe the vapors of any glue, kerosene, gasoline, cleaning fluid or other substance not manufactured or produced for such human consumption for the purpose of becoming intoxicated.
- (b) It shall be unlawful for any person to command, encourage, request, aid or abet any other person to violate the provisions of subsection (a) above.
- (c) A violation of this section shall be punishable by a fine of not less than one hundred <u>fifty</u> dollars (\$100.00150.00), nor more than seven hundred fifty dollars (\$750.00); a second or subsequent violation of this section by the same person shall be punishable by a fine of not less than two hundred fifty dollars (\$250.00), nor more than seven hundred fifty dollars (\$750.00).
- <u>Section 2</u>. This Ordinance is in addition to all other ordinances on the subject and shall be construed therewith excepting as to that part in direct conflict with any other ordinance, and in the event of such conflict, the provisions hereof shall govern.
- <u>Section 3</u>. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
