SUBJECT: Sale of Property

BACKGROUND:

Before the end of last year, the City offered a vacant lot at 232 Everett for a sealed bid. This has been a property the City has offered for sale via a realtor with very little success. The City received two bids for the property with the most responsive one coming from St. Peter's Lutheran Church. They have provided a check to the City in the amount of \$750.

ORDINANCE NO. 4704

**AN ORDINANCE ACCEPTING BID FOR SALE OF CITY-OWNED
SURPLUS REAL ESTATE LOCATED AT 232 EVERETT STREET**

WHEREAS, the City approved selling a surplus parcel of real estate owned by the City located at 232 Everett Street in East Peoria by the sealed bid process pursuant to Ordinance No. 4685, which parcel is legally described in Exhibit A and as depicted in Exhibit B (the "Property"); and

WHEREAS, after adopting Ordinance No. 4685, the City properly published notice for three successive weeks pursuant to the public sealed bidding process as provided under Section 11-76-2 of the Illinois Municipal Code (65 ILCS 5/11-76-2) prior to the bid opening held during the City Council meeting on December 20, 2022; and

WHEREAS, the City received a sealed bid from St. Peter's Lutheran Church ("Purchaser") for the Property in the amount of \$500.00; and

WHEREAS, the City Council hereby finds that the bid presented by the Purchaser is an acceptable bid and the best bid for the Property, and further that this bid should be accepted by the City and the Property should be thereby sold to the Purchaser;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF EAST PEORIA, TAZEWELL COUNTY, ILLINOIS, THAT:

Section 1. The sealed bid from Purchaser St. Peter's Lutheran Church for the Property is hereby accepted by the City.

Section 2. The Mayor and City Clerk are hereby authorized and instructed to execute all documents necessary to effectuate the sale of the Property to the Purchaser upon payment of the bid amount of \$500.00 plus additional closing costs of \$250.00 (as provided by the Notice issued pursuant to Ordinance No. 4685) to the City.

Section 3. This Ordinance shall be in full force and effect from and after its passage by a vote of at least three-fourths (3/4) of the City Council holding office in the manner as provided by law.
