SUBJECT: Solid Waste Automated Arm Replacement

DISCUSSION:

A 2015 Mack Solid Waste truck (#44) needs a replacement automated arm. This arm needs a complete overhaul. The replacement cost estimates a total of \$17,413.38, including shipping. There is a potential of \$3,000 for core charge refunds, but that amount will not be finalized until replacement is completed and the existing arm is returned.

This will be paid for in line item 05-00-0-052.

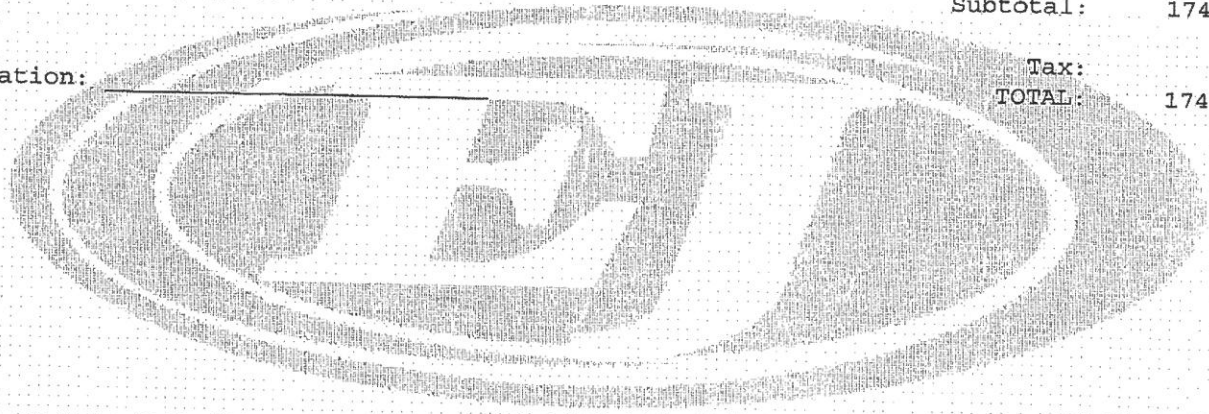
